**DISCOUNT:** The discount for timely filing is 5% on the first \$100 of tax due, plus 2% on any tax over \$100 not exceed a max of \$400 per month/per jurisdiction. (Example: Tax due = \$325, discount calculation would be: \$100 x 5% = \$5.00. PLUS (\$225 x 2% = \$4.50). \$5.00 + \$4.50 = \$9.50 total discount. There is no discount allowed on Consumers Use Tax, Sellers Use Tax or Rental Tax.

**PENALTIES:** Failure to timely file penalty is \$50.00 or 10% of the tax due (whichever is greater), per jurisdiction. Failure to timely pay penalty is 10% of the tax due, per jurisdiction. Additional penalties and interest may apply.
